3. Two letters of recommendation. At least one of the letters must be a professional recommendation (employer, teacher, etc).

**AWARDS:**

1. Applications will be reviewed and recipient selected at the discretion of the National Association of Women in Construction, Tri-Cities Chapter #192.
2. The scholarship recipient will be notified by May 14, 2018. The scholarship award will be posted on the TCCC website by June 1, 2018. The selected recipient will be invited to attend the June NAWIC General Membership Meeting.
3. Checks will be sent to the post-secondary institution in the recipient's name. The scholarship amount for 2018 is \$1,000.00.
